CONSOLACION SUR stalked the pace early, bid four wide after five furlongs, drew off to mid stretch then was under pressure to hold sway late. TOP SPOT looped five wide out of the second turn then was up for the place outside late. DESSERT FIRST vied for the lead from the backstretch to the stretch then weakened. KISSINACOP passed tiring rivals. NEWS raced evenly. RATIONAL VELVET was no factor. SWEETDREAMIN LACEY rushed to the lead outside then came up empty. MARKSWAYORNOWAY pressed inside to the second turn then faded. LEVY LIGHT trailed. THE QUARTER TIME WAS HAND TIMED.
