Footnotes

TWISTED ROPE set a slow pace inside, drew off quickly when asked after six furlongs and was ridden out to prove clearly best. VANTAGGIO hopped then steadied at the break, made a three wide middle move after five furlongs and was second best. SULTRY BAND saved ground much of the way, got through inside after six furlongs but failed to gain. HEAVENLY JOHN raced five wide early, bid after five furlongs then weakened. CAT SONATA pressed the pace four wide then gave way. HI TIDE BOY pressed the winner to the second turn then faded. RUNNINGROOSTER failed to menace. DON'S SWEET STROKE stopped. TAYLOR B trailed.
