OH SO DEBONAIRE dueled past mid stretch before slowly weakening. RIKI MCD looped four wide moving to contention then lodged a mild rally outside. DR. SKIP made a four wide middle move then flattened out. FROST WATCH stalked the pace for six furlongs then gave way. TREASURED KITTEN raced evenly. HAILFELLOW failed to menace. KICKIN' KEY LIME pressed the pace to the second turn then faded. SLIGHT EDGE was through early.
