FAST FASHION dueled to the quarter pole then slowly weakened. TORI LIGHT passed tiring rivals. BLAZING PRIZE raced evenly. PLAYFUL PAL failed to menace. GENERAL JAKE was no factor. MOM EXTRAORDINARY showed little. CHOP SLEWY dueled then stopped.
