### Footnotes

DEVIL'S WEEKEND broke slow, rushed up down the backstretch, waited for racing room in the drive then angled out five wide leaving the furlong grounds and ran down the leaders late. CODY BOY dueled from the outset, held a short lead into the late stages then hung. LITTLESHU stalked the pace inside, angled to the rail in the drive then showed strong stamina to the finish. LET IT BE HARDYBOY dueled early then came again late. CAT PHONE was void off early speed, was in tight inside LITTLESHU in the drive then altered course and angled outside then was gaining late. PURE LIGHTNING dueled past mid stretch then weakened. WALK THE TIGER pressed the pace into the stretch then gave way. DOUBLE DUEL raced evenly. HURRICANE RUSSELL was hung wide. I'M NO CHOIR BOY trailed. Following a stewards inquiry LITTLESHU was disqualified and placed fifth for interference in the stretch.
