IAMTHEONE stalked the pace early, bid in the second turn then came again inside late for the place. SAYYOURPRAYSNOW looped four wide to gain the lead out of the second turn then weakened in the final furlong. JOHORE passed tiring rivals. DECISIVE CALL chased to the second turn then faded. NARROW BACK also chased into the second turn then came up empty. MEEK MAN was used up early. SALT IN MY WOUND was fractious at the gate. WONCENDONE stopped.
