ENTICE made a three wide middle move then was up for the place late while no match for the winner. INNOVATIVE was a bit rank rating off the pace early, bid inside after six furlongs then weakened late. LYDIA'S SMILE fanned five wide then made up some ground outside late. SPANISH AMBASSADOR raced well placed early, bid after five furlongs then gave way in the drive. SASSY SAMI vied for the lead to the stretch then weakened. BOB'S JAWBREAKER raced evenly. NORTHERN WINN was through after a half. CHAPOSASMOKE was through early. GREATSOUTHERN LADY was outdistanced.
