Footnotes

BONNISTAR made a middle move to the stretch, angled inside into the furlong grounds then ran down the leader late. WEKIVA WACHEE rushed to the front four wide into the second turn, drew off a bit to upper stretch then drifted out under pressure in the drive to be caught late. BLAZEN made a middle move through the second turn, angled to the far outside then closed well but too late. NATIVE YELL made a middle move to be in striking distance a furlong out but was outkicked late. STEPS SILVER HALO was well placed into the stretch but failed to respond. ESPINOSA (GB) failed to menace. MR. SEABRA set a slow pace then faded. CHARTER CLASS weakened gradually. GATO PASO broke through the gate pre start then was through early. ROSA PANTERA stopped.
