MY OCEAN BEAUTY broke a bit awkwardly, recovered to make a middle move to contention then bested the rest for the place. PEGASUS PEARL was fractious at and in the gate, came in early, bid in the turn then weakened in the drive. PEACE SMOKE was shuffled back early then failed to gain. INFLATE MY EGO failed to menace. MISS LAURA JEAN was through after a half. AVANDA'S DESTINY pressed the pace outside early then faded. GOLDEN PLAYMATE was no factor. A claim of foul by the rider of PEACE SMOKE against PEGASUS PEARL for interference on the backstretch was disallowed.
