ALEXANDRIA WA broke alertly, set a moderate pace, shook off a bid from SHE'S OUT TO LUNCH leaving the second turn to gain a clear lead then held sway under pressure. WYNN'S AND ROSES stalked the pace inside, angled off the rail in upper stretch but couldn't gain on the winner late. CAVALLO MURANO was well placed into the stretch but also failed to gain. ROAR OF THE KITTY angled well wide out of the second turn but had no rally. MARCIANE failed to menace. SHE'S OUT TO LUNCH pressed the pace to the stretch then came up empty. MISSEQUINS was shuffled back into the first turn then showed little thereafter.
