ECOUTEZ REPETEZ unhurried early, made a quick five wide move to go after the leaders out of the turn, gained a clear lead in the drive then prevailed under pressure. FORBID THE QUEEN was void of early speed, fanned five wide advancing then angled inside in the drive and was up for the place. LEVY LIGHT raced boxed and blocked through the turn, swung six wide to follow the winner in the drive but was outfinished late. GREENER PASTURES stalked the pace early, bid four wide into the stretch then weakened. CURIOSAPRILFIRST raced evenly. BORACAY PRINCESS was taken back early then passed faders. NORTHERNBAMAGIRL also passed tiring rivals. MISS BULLY dueled for five furlongs then gave way. BY WAY OF TEXAS was through after a half. PATIENT CAT was no factor. RAGING ROSIE was used up disputing the pace. HONORWAY stopped.
