GRANDE SHORES set the pace from between rivals, dueled through the lane with POSITIVE ACTION, edged ahead of that one late and held under brisk handling. POSITIVE ACTION vied for the early lead on the outside, dueled with the winner through the lane and was outfinished. BEIJING HOUSE rated in the early going, moved up on the two path through the turn, came three wide to bid and closed willingly through the lane to get up for the show, while no threat to the top two. SAPPHIRE COUNTY stalked the pace on the inside, came through inside of rivals into the stretch and weakened in the drive. PORTER'S GATE allowed to settle, moved up four wide through the turn to gain a striking position, bid on that path and faded in the drive. PRAY was a brief factor, between.
