WAIT'N ON SUMTHIN set a fast pace, resisted gamely when challenged through a long drive then was all out to prevail late. CRIMSON KNIGHT chased from the outset, bid into the stretch then drew even late only to be outkicked to the wire. CHARGING HOME stalked the pace throughout, split rivals in the drive then was gaining outside the top two late. BLAZEN was void of speed for five furlongs then closed fast but too late. BECKHAM BEND was well placed a furlong out but was outfinished late. MY CHARMING CLYDE was also well placed but lacked a strong late response. VANQUISHER was no factor. LEGENDARY KING was through after a half. TERRIFFICO showed little. YANKEE CONNECTION pressed the pace early, stopped then was checked while stopping into the stretch.
