PICAROO was unhurried early, fanned six wide out of the second turn then closed with a rush to be up in the final strides. FUNFAHA broke slow, made a middle move through the second turn, bid four wide through the furlong grounds to gain the lead inside the final furlong then was just caught late. WICKLOW COUNTY was shuffled back in the second turn then came back on again from between rivals late. CHASE AN PAPA raced close up early, bid in the second turn then vied for the lead to the final furlong before weakening. FORTY TEARS raced close up early, bid in the second turn then flattened out. L'ANIMAUX set a solid pace to the final furlong then faded. SHINE BOX made a middle move, was taken up in traffic in the second turn then was forced to take up while attempting to rally along the rail in the drive and failed to recover. CONNECTION BOX was fractious in the gate then broke slow. BOUNDING STAR was also fractious in the gate and also broke slow. DUFFY'S PREDICTION stopped.
