SISTER NAN stalked the pace early, bid three wide into the stretch then drew off steadily under pressure. DEMON'S STORM set a solid pace inside, was no match for the winner but saved the place. GALAXY WIND dueled to wide to the stretch then weakened. WRONG ANSWER was hung seven wide in the first turn then lodged a mild rally. LEVY LIGHT was well placed for six furlongs then gave way. MARK ME raced evenly. HALO'S PRIDE was through after a half. PREMIO MAXIMA was hung seven wide through the first turn. DIVINE SYMPHONY was hung eight wide through the first turn.
