STOLEN HALO made an inside middle move, angled out three wide out of the turn then ran past the leaders through the furlong grounds to win going away. NATIVE WAGER was void of speed for six furlongs, angled out for the drive and was up for the place late. PRINCESS MODISTE chased early, moved to a short lead into the second turn then dueled to mid stretch before weakening. STAR OF COLLEEN L. chased for more than a half, also bid through the second turn to mid stretch then steadied from between rivals while tiring. INNOCENT REMARK passed tiring rivals. BENNY'S GEM raced evenly. PARALEGAL was no factor. HOLMEONTHEWIRE was through early. PLEASANT DEED stopped.
