GAME DRIVE made a three wide middle move, bid four wide in the drive then was up in the final strides. DANCE TO THE ROAR chased the leader early, bid into the stretch, bumped with PEPPERMINT PRINCE in the drive while challenging for the lead then just hung late. PEPPERMINT PRINCE set a solid pace, resisted when challenged in the drive, bumped with DANCE TO THE ROAR then also just hung late. FRIENDS RULE was well placed but lacked a strong late response. PREOCCUPIED passed tiring rivals. DIRECTION TO PAY was well placed to the stretch then weakened. I'M NOT MYSELF raced evenly. CREDIT VOUCHER showed little. CAUSE I SAID was no factor. TRITONK stopped. There was a stewards inquiry held into the stretch run before the results were declared official.
