COLOR ME GRAY looped rivals six wide through to move closest to the winner and was second best then pulled up in apparent distress and was vanned off. LOOSE MOOD dropped back after being close up early then came back on again late. SOBRIETY chased into the stretch then weakened. FLETCHER had no speed and no rally inside in the drive. KAMINSKI failed to menace. SHOWKAYCE 'N ROSES was through after a half. DRUNKEN SPIDER chased to the stretch then came up empty.
