BELAFONTE broke sluggishly, was blocked through the turn but lacked a strong late response once clear. PRIZE MASTER was well placed into the stretch but failed to respond. SKIFF'S ARGUMENT dueled to near mid stretch then weakened. SAMMYTHEREDROCKER broke slow. SPEIGHTSTOWN SON was no factor. ASHQUAR was through early. X MARKER stopped.
