Footnotes

GOSSIP BAY was never far back, bid three wide after five furlongs then dueled through a long drive and was up in the final strides despite having her rider have to stop riding momentarily while getting his whip untangled from his reins inside the final furlong. MECCA'S GOLD dueled from the outset, continued well through a long drive then drifted in nearing the finish. QUEEN OF THE NILE raced close up early, got through along the inside to challenge after five furlongs then also dueled through a long drive before hanging late while steadying inside MECCA'S GOLD near the finish. SET FREE TO FLY closed a gap but too late. MISS MULLIGAN passed tiring rivals. SECRETARIAT BROAD also passed faders. SHOWMETHEOCEAN vied inside to the second turn then gave way. PRIMA DEA broke slow and was no factor. HOOKEDONSWEETNESS stopped. VICTORIA'S CAFE also stopped. There was a stewards inquiry and claim of foul by the rider of QUEEN OF THE NILE against MECCA'S GOLD for interference in deep stretch but was results were left as posted.
