PEARL KEYS was pushed in at the start, dueled to the stretch, shook clear in the furlong grounds then held sway while drifting out then back in late. CHERRY ROAD bumped with DANCE TO ME at the break, raced close up early, bid outside out of the turn but couldn't reach the winner while second best. DANCE TO ME was bumped and in tight at the break then lodged a mild gain late. BOOTEE BABE came in at the break, pressed the pace early then came up empty. SHE IS A KUTIE showed little. MAZIES BLING also came in at the break then stopped. A claim of foul by the rider of DANCE TO ME against CHERRY ROAD and the winner for interference at the break was disallowed.
