STANDING APPEAL broke well, set a moderate pace inside, then shook off rivals leaving the furlong marker and pulled away late. MIDNIGHT SCRIMMAGE made a middle move then was up for the place late while no match for the winner. LACY'S TUNE raced close up early, bid after five furlongs to mid stretch then faltered. NORMANSBIRDIE made a middle move to mid stretch but failed to sustain that rally. IN HONOR OF VOULA raced evenly. POMPANO BEACH ROSE failed to menace. PYRITE HALO chased early, bid in the second turn then flattened out. MIS MAX was well place to the quarter pole then gave way. L P'S TIGER showed little. D. DON'T DANCE was no factor.
