PAR GOLFER made a middle move then split rivals in the furlong grounds to be up late. SONG OF NORA was void of early speed, fanned seven wide out of the second turn then was up for the place despite being carried wide late. INTERNATIONAL CITY fanned six wide out of the second turn, was also carried wide and was outfinished late. LA ROVERINA chased early, bid after five furlongs to gain a short lead then bore out badly in the final furlong. COSMIC RAIN sprinted clear early, resisted well to mid stretch then hung. SINN FREE passed tiring rivals. PICTURESOFMEMORIES raced evenly. NATIVE WAGER raced far back to the stretch. SWINGSVILLE stopped. SILVER TRICON was taken up on the backstretch while bearing out and stopped. The portable inner rail was set at zero feet.
