Footnotes

LADY WINDHAM well placed from the outset, split rivals on the second turn, drove clear leaving the furlong marker then prevailed late under good handling. FUJIYAMA MAMA was void of early speed, advanced after five furlongs and split rivals in mid stretch to be up for the place. LOONEY CREEK was boxed and steadied through the second turn, got through into the stretch to be a threat then was outfinished late. FAMED CITY made a four wide middle move to bid in the furlong grounds then hung late. SHEER BLISS fanned five wide then failed to respond. ESKIMO MOM failed to menace. CUPCAKE was no factor. TANTRUE was hard used disputing the pace to upper stretch and gave way. TEERRIFIC SUE bid through wide into the second turn then came up empty. FERGIE'S WITCH was hard used disputing the pace and stopped. The portable inner rail was set at 22 feet and the race was hand timed. Due to a malfunction in the photo finish system the order of finish was confirmed by placing judges and the final margins were computed by the Equibase field team.
