SOLDIER IN CHARGE made a three wide middle move, fanned five wide out of the turn then ran down the leader late. LIMOSNEYO chased early, bid after three furlongs to gain a short lead then continued gamely to late before just hanging. REPENTS REDEMPTION was void of early speed, fanned six wide out of the turn then closed fast outside late. CAT SONATA stalked the pace for a half, split rivals to challenge in the drive but was outkicked late. DANCE JOCKEY dueled to near mid stretch before slowly weakening. UNBRIDLED GALE failed to menace. ANGELIC FIDDLER showed little. SMOOTH LOVE stopped.
