CHIEF GONE WEST advanced inside down the backstretch, steadied inside COURT ORDER when that one came in into the second turn, recovered to gain a short lead into the stretch then outdueled PIE IN THE SKY late. PIE IN THE SKY was never far back, angled inside the winner into the stretch to challenge along the rail in the furlong grounds but was outkicked late while second best. TASHBAAN was void of speed to the stretch then lodged a mild belated bid. WARACHA bid four wide through the second turn then gave way under pressure. COURT ORDER raced greenly on the backstretch, dropped in into the second turn impeding rivals inside and behind him then weakened in the drive. CONTRARY saved ground to the second turn then struck and attempted to jump the inner rail in the second turn, lost his action badly and was not pressed thereafter. CREAM steadied behind CONTRARY in the second turn. REPRISAL was no factor. SEATTLE THUNDER was forced to steady sharply when COURT ODER came in into the second turn. GREEN PRO was through after a half. Following a stewards inquiry COURT ORDER was disqualified from fifth and placed ninth for interference into the second turn.
