CORREDOR DELA ISLA made an inside middle move to contention, angled out four wide out of the second turn for clear racing room then ran down the leader late. ALBIN raced well placed from the outset, bid into the stretch to gain a short lead only to get caught nearing the wire. FLOWERSONYOURBACK was void of early speed, swung wide in the drive then lodged a belated bid. VIOLA GEORGE dropped over early, rushed to the front then gave way in the drive. GREAT CAUSE steadied leaving the chute, recovered to duel to near mid stretch then weakened. PEACEFUL SLEWTION was well placed but had no rally. SMOKEY THE BANDIT was also well placed but failed to respond. BEANTOWN steadied inside early. PUTHIMINHE'LLWYNN showed little. A claim of foul by the trainer of GREAT CAUSE against VIOLA GEORGE for interference leaving the chute was disallowed. GO TEBOW GO hopped at the start then stopped.
