**Footnotes**

DEVIL GENTLE raced close up inside, moved up in the two path on the turn, came over bothering TESS THE ANGLE while passing that rival midway on the turn, rallied on the rail and drew clear. PURGED N PROPER chased between foes, rallied on the rail turning for home and came up second best. SWEET REPENTANCE raced off the pace, came three wide into the lane and closed belatedly outside. BURN PERMIT dueled four wide, then three wide on the turn and tired. TIME FOR A DIME chased inside and lacked a bid. WHO'DATHUNK chased outside and tired. STRAIGHTTOTHEBANK dueled between rivals and tired. STEVES LADY dueled five wide early, four wide on the turn and faded. TESS THE ANGEL dueled in the two path, then chased on the rail and was forced to check sharply in tight quarters at the five sixteenths marker. After a Jockey's Objection and Stewards' Inquiry, DEVIL GENTLE was disqualified and placed last.
