Footnotes

DONTBOTHERMENOW was never far back while racing along the inside, moved up to take a slight edge approaching the stretch and edged away late. HAYATI SON raced off the pacesetters early, moved up from the outside to offer a bid nearing the three-sixteenths pole, drifted in to bump WILKO'S BULLET nearing the eighth pole, drifted inward again nearing the sixteenth marker and finished with good energy when straightened away. WILKO'S BULLET was bumped at the break, raced off the leaders early, moved up from the outside to offer a bid nearing the quarter, was bumped by HAYATI SON soon after, steadied from that rival's drifting between the eighth and sixteenths markers, angled out and finished with a steady rally. DA DON dueled for the early advantage from the outside, was bumped while retreating between the furlong and sixteenths poles and continued to give way thereafter. SAINT SPEEDY lacked early speed, raced far wide through the second turn and finished evenly in the drive. ENDURING CAUSE dueled for the lead from the inside for a half and weakened. CHIEF AGAIN lacked early speed, raced off the rail, dropped far back and was eased through the stretch. SEEKING HARMONY was bumped at the start, chased the leaders from the outside, weakened after going a half and was eased through the lane. CASH FOR CASH was bumped at the start, dropped far back, raced wide through the second turn and was also eased through the stretch. The stewards conducted an inquiry concerning the steadying of WILKO'S BULLET between the eighth and sixteenth pole and after reviewing the films concluded HAYATI SON had caused the

infraction by drifting in and was disqualified from second and placed third.
