STARLIGHTER chased the leaders from between foes, moved up to offer a bid in tandem with BEAT YOUR BLUFF nearing the three-sixteenths marker, vied with that foe into deep stretch and proved best by a narrow margin. BEAT YOUR BLUFF pressed the pace of GARCON from the outside, moved up with the winner to vie for the lead into the lane and just missed. GARCON was bumped at the start, set a pressured pace from the inside and gave way to the top pair grudgingly in the drive. SPEED LIGHTNING raced off the pacesetters early, moved outside through the turn and finished evenly. EIGHT RIDERS was void of early speed, raced far wide through the turn and found his best stride late. FLY DIXIE was bumped at the start, lacked early foot, raced wide through the turn, reached a contending position in mid-stretch and finished evenly late. HIYABEN chased the leaders from the inside and gradually weakened. PERSONAL GOOD raced off the pacesetters from the inside and weakened after going a half. CAPTAIN CHRIS raced off the leaders from between foes and also weakened in the drive. GIMMEAWINKPOPPY was void of early speed, saved ground throughout and failed to rally.
