SHOW ME SOME RYTHM made an inside middle move, angled to the middle of the course in the drive then rallied past the leader leaving the furlong grounds. TEN BOLTS stalked the pace early, got through in the second turn to gain a short lead but hung late while saving the place. THE LADY WAFFLES raced close up early, bid after five furlongs then was outkicked late. SLICKENSIDE fanned six wide in the drive then gained some ground late outside. CHIC CAT lodged a mild rally inside. MEDDLING was fractious in the gate, set a moderate pace then weakened. KERI'S ANGEL failed to menace. OFFBEAT FASHION (IRE) was checked and steadied along inside early, was angled out on the backstretch then after rushing up four wide, came up empty. HARMONY FOUND failed to menace. DREAMLINER was also fractious in the gate and stopped.
