ROEDDON tracked early, moved up outside to press the pace, bid at the quarter pole and prevailed after a long drive. DON'T LOCK ME OUT set the pace and dug in gamely on the rail to the finish. ZANGADO was bumped at the start, raced off the pace inside, angled out in upper stretch and finished well outside. DUAL CITIZEN settled outside a rival, came wide for the drive and lacked a rally. CHILL OUT CAT was bumped at the start, saved ground and failed to rally. ARONEY raced off the pace and failed to threaten. SKY TOWN stalked in the two path and tired. O'SHEA was outrun. DR. KENNEY was outrun. GO TEBOW GO raced off the rail and faded.
