XUNLEI raced five wide in the early stages, rallied four wide past the quarter pole and drew clear in the final furlong. CITIZEN ADVOCATE dueled inside, cleared off on the turn and dug in gamely to save the place. BACKSTAGE MAGIC chased three wide and finished evenly. NORTHERN COTTON chased four wide and weakened. PRICKLY PEAR dueled two wide and tired. POLISH TUNE raced six wide early, three wide on the turn and failed to rally. BIANCA NEVE saved ground to no avail.
