MY SUNSHINE GAL vied for the early lead inside, shook clear into the stretch then drew off steadily when set down for the drive. DEVILISH LADY stalked the pace for more than a half, bid four wide out of the turn but was no match for the winner while gaining the place late. WHITE MERLOT also stalked the pace, bid three wide leaving the turn but weakened in the drive. BE MY CANDY made a middle move to upper stretch but failed to sustain that rally. SNOW TRIAL failed to menace. BROADWAY MARQUEE rushed to the lead along the rail after a quarter then came up empty. DADDY'S HONOR was through after a half. MY PAL CHRISY was no factor.
