CROWN COLONY (GB) pressed the pace inside to the stretch then weakened. POPLARSAINT broke slowly then passed tiring rivls. QUINCEY APPLE was through after a half. DAYTONA BOUND showed speed to the turn. RUN TO THE MAX failed to menace. TRIPLE WORD SCORE broke through pre start then flashed brief speed. CATONINE trailed.
