BLAZING PRIZE chased early, bid four wide in the turn then edged clear after a long drive. TAWNIMARA dueled from the outset, continued gamely through a long duel then just hung late while second best. UNO WAY CALLE was well placed but failed to gain. WONGONEWILD vied to the quarter pole then weakened. WESTERN PIRATE was taken up at the break. PAYYOURTAX faded after a half. WILD INQUIRY showed little.
