WADOCASHSKI was void of speed to the stretch then lodged a belated bid to be up for the place while no match for the winner. I FOUND SWEETIEPIE made a middle move to the second turn but failed to sustain that bid. MARKS CHOICE failed to menace. FOXY VALLEY GIRL set a moderate pace then faded. CATTY PATTY chased to the second turn then gave way. LIGHTNINGONLINE stopped.
