SWEET TIMBER made a middle move in traffic and was easily second best while no threat to the winner. NORTHERN EDGE chased the winner to mid stretch then weakened. NOLA was well placed outside into the stretch then gave way. SHE'S DUE FOR ONE was through after a half. GLACIAL BREEZE failed to menace. RUNNAWAYTINA showed little. GAS CAN raced wide early then stopped.
