HOOH WHY raced well placed early, bid after five furlongs then shook clear and drew off through the late stages. BRINCA made a middle move, came in during the drive for a bit before being straightened and outfinished the rest. ANOTHER SMOKEY was void of early speed then lodged a mild rally late. SWINGING CRUISE dueled for six furlongs then steadied inside BRINCA in the drive. CARTIER LADY was no factor. TRUE EXPECTATIONS was through early. WHITE MERLOT vied early, stopped suddenly after a half then was being eased late. There was a stewards inquiry and claim of foul by the rider of SWINGING CRUISE against BRINCA for interference in the stretch but no action was taken.
