FABLEDZAPPER set a solid pace, resisted to late before hanging then saved the place. PORCUPINE was well placed but lacked a strong late response. GIBSON COUNTY LINE chased the leader early challenged after five furlongs then weakened in the drive. STARLIGHTER raced evenly. SWIFT STRIKE failed to menace. PATRIOTIC DREAM was no factor. KING OF CANDYLAND chased early, bid in the second turn then came up empty. TAP'N MY TOES showed little.
