RIO GREY raced close up early, bid three wide in the second turn bur was no match for the winner in the drive while second best. GOLD STRIKE BEGINS pressed the pace early, gained a short lead in the second turn then weakened in the derive. DIAMOND WILLIE made a middle move then flattened out. SILVER EAGLE failed to menace. CONRAD CROSSING was no factor. HOLIDAY BOY set a slow pace early then faded. GIMMEAWINKPOPPY showed little. BABO trailed.
