TWO FRANKS ALLY dueled two wide from the outset, resisted the winner when challenged into the stretch then also continued gamely to late before just hanging while saving the place. PRINCESS LOLA was in tight in the turn while making an inside middle move, angled off the rail into the stretch then swung back to the inside to challenge in the furlong grounds then also hung late. MYSTERIOUSNESS raced evenly. LIL'S NOVA dueled inside to upper stretch then gave way. HALO'S BEST raced wide in an even trip. HALLUCINATION was through after a half. FUN ON THE WEEKEND showed little. TRY A THING trailed.
