GERALDINE'STHUNDER pressed the pace three wide, bid after three furlongs then after dueling through as long drive, was all out to narrowly prevail. BOBBY'S BELL broke slowly, rushed up inside then was boxed behind and inside rivals through the turn and forced to wait for racing room, split rivals into the final furlong and finished gamely to just miss. HARLAN'S PEPPER dueled from the outset then continued gamely through a long drive before just hanging late. ESSENCE OF TIME was hung four and five wide much of the way then lacked a strong late response. PRAYERS AT MASS was hung four wide to the quarter pole then gave way. MISS SEDUCTION raced evenly. PEACEPHILLY was no factor. SIMPLY IMPRESSIVE showed little. LAWYER JEN stopped.
