THATLLEAVEAMARK set a solid pace into the stretch, was no match for the winner but saved the place. FLEETER raced well wide through the turn and into the stretch then made a mild gain outside late. GIBSON COUNTY LINE made an inside middle move, got through along the inside in the drive then lodged a mild rally late. MORE THAN A REASON was hustled along to hold a striking position into the stretch then weakened. SCALLION raced evenly. SCORE ONE was no factor. CHIEF REDNECK was through after a half. BEIJING HOUSE failed to menace. FLAWLESS N SEATTLE stopped.
