MAUI ESCAPADE was hung wide early, bid leaving the turn but was no match for the winner while outfinishing the rest. BONZI vied early, shook clear into the turn then continued well to mid stretch before weakening. HEFFERMAN made a middle move to the stretch but failed to sustain that rally. SLY AND STICKY chased to the quarter pole then faded. CHANTEL BY THE SEA passed tiring rivals. READY TO FIGHT raced evenly. SALTY'S ACTOR was through after a half. FUTURE DRAMA also gave way after a half. CONSECUTIVE HIT was no factor. MR. PANACCIONE bolted approaching the turn. MERTON'S HEART stopped.
