CHANTY LIGHT was well placed into the stretch then weakened. SHES NOTABLE passed tiring rivals. POINT JUDITH was no factor. EMILY'S FLYOVER was through after a half. MY DAY WILL COME flashed brief speed. ELECTRICA was no factor. BLONDE BULLET stopped.
