NORMATIVE APPEAL was never far back, bid after six furlongs then shook clear and drew off smartly late. BIG APPLE LADY made a middle move after five furlongs then was up for the place late. LIBERTY LEIGH made an inside middle move, angled to the middle of the course but could offer only a mild rally late. COWGIRL KITTY was well placed after six furlongs but had no rally. BEVERLY'S CHARM was hung four wide trying to advance through the second turn then gave way. CATRIANA CAMILLE set a moderate pace then faded. SWEEPLE was no factor. CHOLY was through early. MARCH BACK TO ME stopped. ZENNIN GIRL trailed.
