SELF stalked the pace inside, got through along the rail to challenge in the drive then narrowly prevailed after a stiff drive while brushed late by LAST OUT OF PANAMA. LAST OUT OF PANAMA broke slow, looped rivals four wide to challenge out of the turn then drifted in during the drive and brushed with the winner late. MYLES was well placed but failed to gain. JO ANN'S BULLET chased outside, bid into the stretch to be a threat a furlong out then steadied inside LAST OUT OF PANAMA while tiring. DIMES TO DOLLARS drove clear inside into the turn, dueled to mid stretch then gave way. BIG BROWN SHOES raced evenly. MEEK MAN was through after a half. DUFFY'S PREDICTION trailed. There was a stewards inquiry and claim of foul by the rider of JO ANN'S BULLET against LAST OUT OF PANAMA but the original order of finish was permitted to stand as posted.
