R B HIGHER GROUND raced close up outside from the outset, bid into the stretch then drew off late under pressure. SABAGO stalked the pace for five furlongs, angled outside in the drive then was up for the place. BLYDE RIVER BOY got through inside to challenge early, gained a short lead in the furlong grounds then weakened. DENY dueled to mid stretch then gave way. SILVER TUXEDO was in tight inside in the turn then lacked a late response in the drive. SAM C. raced evenly. PROUD MONKEY pressed the pace for five furlongs then faded. MY SISTER MERRY was no factor. NO SHOW BILL was through after a half. SUNNYDANCE showed little. STAG FILM was no threate. TRIAL RIDGE failed to menace.
