LA HERNANDA (IRE) made a middle move through traffic through the second turn, angled out four wide to challenge in the furlong grounds then bore out badly inside the final furlong before shaking clear late. BALLYMORE LADY followed LA HERNANDA through traffic through the second turn, bid five wide in the furlong grounds then was carried out badly by that one in the late stages. LIL'S LASSIE stalked the pace, bid into the stretch to gain a short lead a furlong out but weakened under pressure. STREET SOUNDS stalked the pace early, was shuffled back in traffic in the second turn and failed to fully recover. PAY THE MAN vied for the lead to mid stretch then gave way. HAPPINESS IS was well placed to the stretch then faded. FIRST ASCENT showed little. DIAMOND DINA stopped. GRAND IN GREY also stopped. Following a stewards inquiry and claim of foul by the rider of BALLYMORE LADY, LA HERNANDA was disqualified and placed second.
